## Introduction

These Website Standard Terms and Conditions written on this webpage shall manage your use of our website, Clickbid accessible at <https://crossroads.cbo.io>

These Terms will be applied fully and affect to your use of this Website. By using this Website, you agreed to accept all terms and conditions written in here. You must not use this Website if you disagree with any of these Website Standard Terms and Conditions.

Minors or people below 18 years old are not allowed to use this Website.

## Intellectual Property Rights

Other than the content you own, under these Terms, Crossroads International and/or its licensors own all the intellectual property rights and materials contained in this Website.

You are granted limited license only for purposes of viewing the material contained on this Website.

## Restrictions

You are specifically restricted from all of the following:

## Shipping and lost/damage items

- A shipping cost that is to be determined may be applied to your item under the following conditions
  - Size and weight of the item
  - Location of where the item is located and where it will be shipped to
- Crossroads International will only ship to residents that live in Canada and provide a valid Canadian address
- Items will start to be shipped out a week after the event has closed
- Crossroads International shall not assume any liability for lost or damaged items.

## Tax receipts:

Per the Canada Revenue Agency (CRA), Crossroads International can only issue receipts for items that have the fair market value (FMV) listed. For any auction item, we cannot issue a receipt if the fair market value is not displayed prior to the auction. If the fair market value is listed, we have to obey the 80% rule.

**The 80% rule:** a simple way to calculate the minimum bid for which an official donation receipt can be issued is to multiply the fair market value of the auction item by 1.25. Therefore, an auction item with a fair market value of \$100 multiplied by 1.25 equals \$125. This means, in this example, that a minimum bid of \$125 is required before an official donation receipt can be issued and the receipt would be for \$25 (if the winning bid is \$125).

Tax receipts will be issued by no later than February 28<sup>th</sup>, 2022.
